With reference to your candidature for the above post in Navodaya Vidyalaya Samiti, I am directed to offer you a post of Principal, on temporary basis in NAVODAYA VIDYALAYA SAMITI (NVS) with place of posting at **JNV Kupwara (J&K)**, on the following terms and conditions:-

- 1. The scale of pay attached to the post of Principal is in Level-12 (78800-209200) in the Pay Matrix. Your initial pay in this scale will be fixed as per Govt. of India rules. You will also be eligible for the usual allowances admissible under the rules and orders in force, from time to time.
- 2. You will be on probation for a period of two years from the date of appointment extendable at the discretion of the Competent Authority. Failure to complete the period of probation to the satisfaction of the Competent Authority or being found unsuitable for the post during probation period will render you liable to be discharged from service anytime without any notice and assigning any reasons thereto.
- 3. Your appointment will be subject to your being found medically fit by the Competent Authority for appointment to the aforesaid post. This offer of appointment is liable to be cancelled, if you are not found medically fit. - 5. On appointment, you will be required to take an oath of allegiance to the constitution of India and make a solemn affirmation to that effect in the enclosed form.
- 6. The appointment will be further subject to the submission of a marital declaration in the form enclosed and in the event of your having more than one spouse living, the appointment will be subject to your being exempted from the enforcement of the requirement in this behalf.
- 7. You shall declare your Home Town within a period of six months of your joining the duty in the NAVODAYA VIDYALAYA SAMITI.
- 8. NVS prima facie follows Govt. of India rules in vogue mutatis mutandis on service matters.
- 9. On your joining NVS, you will be mandatorily covered by the New Pension Scheme. In case you are already an employee of the NVS, then rules / instructions of NVS will be applicable in this regard.

 - v) Medical Certificate of fitness from the Civil Surgeon (copy enclosed and to be submitted at the time of joining).
 - vi) Oath of Allegiance.
 - vii) Martial Declaration.
 - viii) Details of family.
 - ix) Attestation form in triplicate. (Copies enclosed and to be submitted at the time of joining).
 - x) Last Pay Certificate. (In case of person already employed in Govt. service).
- 11. If any declaration of information furnished by you proves to be false or if you are found to have willfully suppressed any material information at any time for getting this job or otherwise, you will be liable for removal from service and to such other action as Samiti may deem necessary.

- 12. Any canvassing regarding posting will not be entertained and may result in cancellation of the offer of appointment. No request for change of posting will be considered.
- 13.
